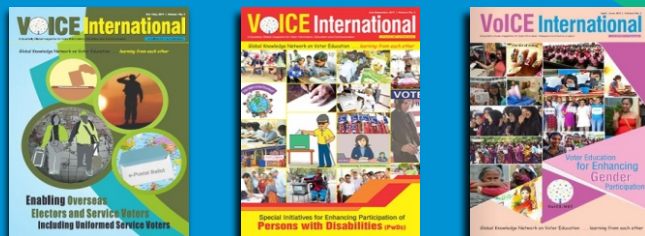
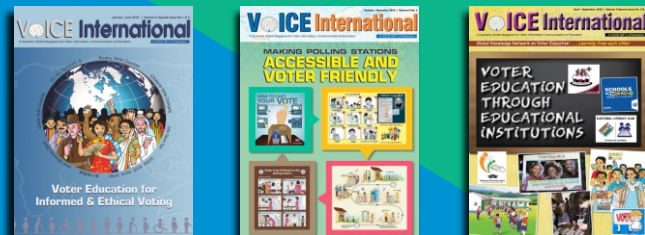
An Introduction



VoICE.NET (Voter Information, Communication and Education Network) is a global knowledge network for sharing knowledge, resources and expertise on Voter Education. It serves as a repository of data, education tools, research papers, creatives and best practices on voter education.

It was launched in October 2016 at the International Conference on Voter Education for Inclusive, Informed and Ethical Participation held at New Delhi and adopted by 25 EMBs and international organizations. At present, VoICE.NET has 29 active partners (EMBs and International Organizations) and numerous other associates across the world.
